The 2021 August CSTR ride is open to all members regardless of vaccination status pending any changes in Massachusetts regulations.

IMPORTANT POINTS TO REMEMBER

The process will be a little different this year. The timeline for registration, transmittal of necessary documents and payment is very short. All necessary paperwork is required to be completed and submitted by **July 30th**. The limit of 100 horses is still in place.

1. Complete online 2021 CSTR Ride Registration form <https://forms.office.com/r/pcf99ADCVA>. one form PER attendee - **This will go directly to Loretta Vincz**
2. A signed entry form/liability waiver must be forwarded **ASAP to Pat Darmofal**. It may be electronically signed and emailed or printed and signed and postal mailed or scanned in and emailed.
3. Along with the liability waiver, attach or forward other necessary documents (Coggins, Rabies etc)
4. Payment can be made by mailing a check to **Pat Darmofal, 12 Kelly Street, Haverhill MA 01832** and made out to Cross State Trail Ride.
